

The Polish Financial Supervision Authority approves the supplement no. 10 to the information memorandum of Bank Gospodarki Żywnościowej S.A. (now operating under the business name of "Bank BGŻ BNP Paribas S.A.") prepared in connection with the merger of Bank Gospodarki Żywnościowej S.A. with BNP Paribas Bank Polska S.A.

The Management Board of Bank BGŻ BNP Paribas S.A. (the "Bank") (previously operating under the business name "Bank Gospodarki Żywnościowej S.A.") hereby informs that:

(1) on 15 May 2015 the Polish Financial Supervision Authority ("PFSA") approved the supplement no. 10 to the information memorandum of the Bank prepared in connection with a public offering of 28,099,554 ordinary series I bearer shares of the Bank with a nominal value of PLN 1 each (the "Merger Shares"), carried out by the Bank in connection with the merger of Bank Gospodarki Żywnościowej S.A. with BNP Paribas Bank Polska S.A. with its registered office in Warsaw, as well as in connection with the application for the admission and introduction of 28,099,554 Merger Shares to trading on the regulated market (main market) operated by the Warsaw Stock Exchange, approved on 16 February 2015 by the decision of the PFSA no. DPI/WE/4170/1/6/15; and
