

## Issuance of Bank BGŻ S.A. Certificates of Deposit

### **Current report 99/2012 dated August 29, 2012**

Management Board of Bank Gospodarki Żywnościowej ("Bank"), hereby informs that on August 29, 2012 under the agreements signed on March 14, 2008 in relation to Certificates of Deposit issuance program ("CDs") the Bank issued the following tranches.

1. 50 pcs. of zero-coupon CDs with a nominal value 500 000 each and total value of PLN 25 000 000 with an issue price of PLN 479 771,00 each;
2. 50 pcs. of zero-coupon CDs with a nominal value of PLN 500 000 each and total value of PLN 25 000 000 with an issue price of PLN 473 227,00 each;
3. 100 pcs. of zero-coupon CDs with a nominal value of PLN 500 000 each and total value of PLN 50 000 000 with an issue price of PLN 486 329,00 each.

Certificates of deposit issue program is used to finance Bank's current credit activities.

The agreements dated March 14, 2008 relating to a program for the issuance by the Bank of Polish zloty denominated short- to medium-term bearer securities in the form of certificates of deposit up to maximum amount of PLN 2.5 billion were described in the Bank's prospectus approved by the Polish Financial Supervision Authority on April 28, 2011.
