What is this product?

The Sprott Physical Uranium Trust (the “Trust”) is a closed-end mutual fund trust established under the laws of the Province of Ontario, Canada. Each trust unit represents an equal, fractional, undivided ownership interest in the net assets of the Trust attributable to the particular class of trust units. The Trust was created to invest and hold substantially all of its assets in physical uranium. The Trust is listed on the Toronto Stock Exchange (the “TSX”) under the symbol “U.U” (in U.S. dollars) and “U.UN” (in Canadian dollars).

Objectives

The Trust was created to invest and hold substantially all of its assets in physical uranium. The Trust seeks to provide a secure, convenient and exchange-traded investment alternative for investors interested in holding physical uranium without the inconvenience that is typical of a direct investment in physical uranium. The Trust does not anticipate making regular cash distributions to unitholders.

Intended retail investor

This product is intended for investors who are looking for exposure to physical uranium in a liquid format, and are able to bear the potential risk of loss of capital up to the amount invested in the Trust.

Insurance benefits

The Trust does not offer any insurance benefits.

Term

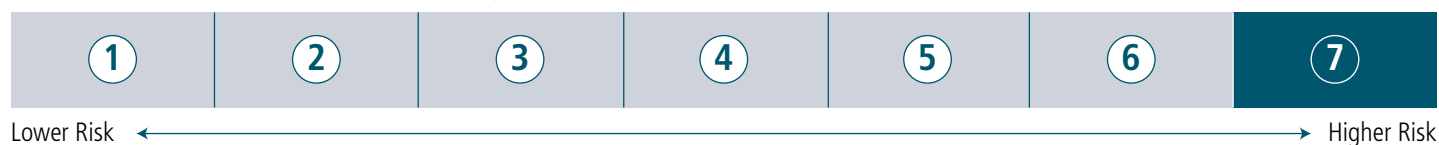
The Trust does not have a fixed termination date but will be terminated in the event there are no trust units outstanding, the Trustee resigns or is removed and no successor trustee is appointed by the Manager by the time the resignation or removal becomes effective, the Manager resigns and no successor manager is appointed by the Manager and approved by unitholders by the time the resignation becomes effective, the Manager is, in the opinion of the Trustee, in material default of its obligations under the Trust Agreement and such default continues for 120 days from the date that the Manager receives notice of such default from the Trustee and no successor manager has been appointed by the unitholders of the Trust, the Manager experiences certain insolvency events or the assets of the Manager are seized or confiscated by a public or government authority.

In addition, the Manager may, in its discretion, terminate the Trust, without unitholder approval, if, in the opinion of the Manager, after consulting with the independent review committee, the value of the net assets of the Trust has been reduced such that it is no longer economically feasible to continue the Trust and it would be in the best interests of the unitholders to terminate the Trust, by giving the Trustee and each holder of the trust units at the time at least 90 days’ notice. To the extent such termination in the discretion of the Manager may involve a matter that would be a “conflict of interest matter” as set forth under applicable Canadian securities legislation, the matter will be referred by the Manager to the independent review committee for its recommendation.

In connection with the termination of the Trust, the Trust will, to the extent possible, convert its assets to cash and, after paying or making adequate provision for all of the Trust’s liabilities, distribute any available net assets of the Trust to unitholders, on a pro rata basis, as soon as practicable after the termination date.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years. What happens if the Spratt Physical Uranium Trust is unable to payout?

You may face a financial loss should the Manager, Trustee or the Custodian default on their obligations. In the event of the insolvency of the Manager or Trustee, the Trust’s assets held by the Custodian will be not be affected, but the market value of your investment may change until your investment is liquidated. The underlying uranium of the Trust is held in safekeeping in various storage locations around the world. In the event of the insolvency of the Storage Provider, the uranium should be protected from such insolvency as it is held in an allocated account separately and distinctly from other uranium of the Storage Provider and any other clients.

In accordance with the conditions outlined in the Prospectus and with the prior approval of the Canadian Securities Authorities, the Manager may temporarily suspend redemption rights under certain conditions.

What are the costs?

Costs over time
